Taught a course for graduate students focused on principles of ethical thinking and practice affecting the work of the family professional, and developing a professional identity.

Taught a course for undergraduate students focused on concepts and critical issues related to the diversity of American families, with particular emphasis on ethnicity and social class.

Curriculum Development

<u>Michigan State University:</u> Revised a course for the undergraduate Human Development and Family Studies program to align it with its CFLE approved program credential with the National Council on Family Relations (NCFR).

Introduction to Human Development and Family Studies, 2015, significant revisions involved changing the focus of the course from a human services perspective to a family science perspective and introduces students to the wide range of potential fields within family science, such as family life education, marriage and family therapy, and many more. Students apply for student membership with NCFR, and explore the resources of this professional organization. They are introduced to the process of becoming a certified family life educator (CFLE), including awareness of the 10 content areas of family life education, with an emphasis on ethical considerations of the professional. Students also explore professional development and program development.

Spring Arbor University: Wrote curriculum for two courses for the Master of Arts in Family Studies program in preparation for application to the National Council on Family Relations for CFLE approved program status. In addition, revised the final program project and two courses to update readings and increase program rigor. The two new course descriptions are listed below, followed by descriptions of course revisions:

- Parenting in Context, 2008, in this course students explore the interactional and multidimensional contexts that impinge on the mothering and fathering roles. Students explore how the characteristics of parents affects child development and outcomes, how the characteristics of the child influence parents, and how contextual issues such as marriage, work, community/neighborhood, socioeconomics, and wider sociocultural values, beliefs and norms impact both parent and child outcomes.
- Human Development Across the Lifespan, 2011, in this course students explore a multifaceted approach to human growth and development that spans the lifetime. The focus of readings and discussions are on factors and processes influencing normal development, as well as how families adjust to developmental delays, disabilities, and loss at any stage of the life cycle. Multiple theories of development are considered, along with an exploration of current research and classic literature on the human lifespan.
- Final Program Project, 2012, through this project students develop, implement and evaluate a family life education program in their communities. Revisions were made to increase program rigor and include seven new or enhanced components: mini proposal, internship with a community agency to implement the program, enhanced needs assessment requirement, enhanced evaluation requirement, logging of hours and reflection of time spent in program development and implementation, attendance at a conference or professional development workshop, and enhanced conclusion.
- Family Studies Methodologies I & II, 2013, previously one course, this course was divided into two parts in order to better fit into SAU semester schedules. The division provided an

opportunity to focus scholarship for better preparation for program development. The first part focuses on introduction to the field of family studies and on the three-fold role of theory for practice. Several theoretical frameworks are studied. The second part of the course focuses on four areas of program development: the use of logic models, writing goals and objectives, planning for evaluation, and preparing for the literature review process.

Research Methods, 2013, in this course graduate students focus on the foundations of scientific inquiry, including research design, data collection, quantitative and qualitative techniques, and interpretation. The revisions will add a statistics component, and will focus on evaluation research as the specific platform for learning about scientific inquiry. Students will gain a good understanding of the value, methods, and tools of evaluation. As consumers of evaluation research, they will be equipped to consult with evaluators and maintain performance management of programs.
